
Description of this fund

The Lifetime UK Cash Fund seeks to track the Sterling Overnight Index Average (SONIA) (in NZD) (before annual fund charge and tax). The Fund invests 100% into a GBP Cash Account and is expected to experience low to moderate volatility.

What are the risks of investing?

Risk indicator for the Lifetime UK Cash Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.

Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$770.11 (that is 7.70% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$770.11 for the year.




Actual investment mix
