Lifetime Australasian Shares Fund

What is the purpose of this update?

This document tells you how the Lifetime Australian Shares Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Lifetime Asset Management Limited (**Lifetime**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Lifetime Australian Shares Fund will seek to track composite indices (before annual fund charge and tax), comprising, 70% Morningstar New Zealand (total return) Index, including imputation credits and 30% S&P/ASX 200 Accumulation Index (in NZD). The Fund provides exposure to New Zealand and Australian shares and is expected to experience high volatility.

What are the risks of investing?

Risk indicator for the Lifetime Australasian Shares Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Specific risk

In addition to the general investment risks, you should be aware this Fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. This could result in negative or lower than expected returns compared to a fund which is diversified across multiple asset classes.


The market index annual return for the Fund is a composite index, calculated using the return of each index the Fund invests in, weighted by the Fund's benchmark asset allocation. On 1 March 2023, the composite index was updated due to the changes to the underlying funds in which the Fund invests.

Small differences in fees and charges can have a big impact on your investment over the long term.


Example of how this applies to an investor

Ben had \$10,000 in the Fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges and tax were deducted of \$268.49 (that is 2.68% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total return after tax of \$268.49 for the year.

What does the fund invest in?


Actual investment mix³

Notes

1. The Manager's basic fee has been estimated using the average amount payable by an investor. During the year different fees may have applied to investors depending on when they joined, whether their account is locked-in and if they negotiated an ongoing fee with their financial adviser.

On 1 March 2023, Lifetime Asset Management Limited took over as manager of the scheme from AMP Wealth Management New Zealand Limited. From 1 March 2023, tiered fees associated with when an investor joined or whether their account was locked-in were removed and replaced with a flat percentage fee.

On 1 October 2023 the administration fees reduced to 1.03% and on 1 January 2024, it will reduce to 0.98%.

- 2. The other management and administration charges include estimates of underlying fund charges provided by underlying fund managers. To estimate the charges, Lifetime calculates the benchmark weighted average underlying investment management cost.
- 3. The actual investment mix has been calculated including cash and cash equivalents held for operational purposes. This operational cash & cash equivalents holding can be negative under certain circumstances (such as the timing of withdrawals requests and the Fund having cash to pay this withdrawal). On 30 September 2023, the Fund had a negative operational cash holding.
