
Description of this fund

This is a single sector fund with a diversified portfolio of international fixed interest securities. The fund aims to primarily preserve the value of your investment with some capital growth by investing in fixed interest securities issues in bond markets around the world (which may include NZ bond markets).

What are the risks of investing?

Risk indicator for the AMP Global Fixed Interest Fund No. 2:


In addition to the general investment risks, you should be aware this fund is concentrated in a particular asset class and not diversified across multiple asset classes. At any given point, market conditions that cause one asset class to perform well may cause another asset class to perform poorly. ^{*} Based on a decrease in administration charges, underlying fund manager expenses and other expenses, the Manager estimates that the total fund charges for the next scheme year will reduce to 0.95% of the net asset value.


Example of how this applies to an investor

Craig had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Craig incurred a loss after fund charges were deducted of \$365.00 (that is -3.65% of his initial \$10,000). Craig also paid \$0.00 in other charges. This gives Craig a total loss after tax of \$365.00 for the year.
